Lot 24 Plan Amendment Review	asked how construction of the original design could cost an additional \$25,000. Julie Korenko, Insitu, said that because they are no longer using pilings, the original design would require cutting and lapping the new geo-grid fabric and penetrating through grade beams. Thornsbury said that if the Port had been notified of the modification, paving of the road could have been delayed to allow for installation of another sewer connection. Korenko said it was an oversight and that is why nothing was said. PC Schmitt pointed out that repairs to cut pavement never hold up. Discussion followed regarding alternative locations for the sanitary sewer service connection.	and permit use of an alternate design extending the existing sewer line south or using the existing western sewer service, PC Vinyard S, MP.
	Thornsbury said that based on its costs for the BP Infrastructure Improvement Project, the sewer line installation costs could be estimated at \$38 to \$40 per lineal foot. Korenko said one option would be to utilize the western service connection instead, adding 120 feet of sewer line and	
	reduce the amount saved by \$9,000, if there are no geo-technical issues. PC Vinyard said that the estimated cost should be partially offset by the cost reduction resulting from not having to tap the sewer main and repair and repave the road. PC Schmitt stated his preference that Insitu use the existing sanitary sewer connections. PC Vinyard noted that the new option would work and through it would add some cost to the project, it
