RESOLUTION NO. 17-2010

A Resolution of the Port of Klickitat Commission
Establishing Dallesport Industrial Park Water Rates

WHEREAS, the Port owns a non-community public water system in Dallesport, Washington, that provides water to tenants of its Dallesport Industrial Park and adjacent properties; and

WHEREAS, the Port is responsible for maintaining, upgrading, improving, and protecting its public water system in accordance with the requirements established by the Washington Department of Health;

NOW, THEREFORE, BE IT RESOLVED that the Port Commission, in order to fund the operation, improvement, and expansion of its public water system, hereby establishes the water rates, fees, and charges as described in the following document entitled *Dallesport Industrial Park Water System Rates, Fees, and Charges – 2011*, the provisions of which are hereby incorporated by reference. These rates shall be effective January 1, 2011.







**Dallesport Industrial Park Water System
Rates, Fees, and Charges – 2011**

Monthly Charges

A BASE (MINIMUM) MONTHLY FEE IS CHARGED BASED ON THE SIZE OF THE METER, EVEN WHEN NO WATER IS USED.

USAGE IS CHARGED AT THE SPECIFIED RATE FOR EACH 1,000 GALLONS OF WATER USED.

CHARGES FOR METERS LARGER THAN 8" ARE DETERMINED ON A CASE-BY-CASE BASIS.

Connection Charge

EACH NEW CONNECTION TO THE WATER SYSTEM REQUIRES PAYMENT OF A CONNECTION CHARGE BASED ON THE CONNECTION SIZE.

CHARGES FOR CONNECTIONS LARGER THAN 8" ARE DETERMINED ON A CASE-BY-CASE BASIS.

Standpipe/Hydrant Use

Customers are charged a one-time \$25 (standpipe) or \$75 (hydrant) fee at the time of each application for use. All usage is charged at the rate listed above for 500,001 gallons or more. There is no connection or base charge.

Late Payments

Payments over ten (10) days past due will be assessed a fee of \$10.00. Payments over forty-five (45) days past due will result in the disconnection of water service. Overdue balances will be assessed interest of twelve percent (12%) APR.

Rate Increases

All rates, fees, and other charges described herein will automatically increase by three percent (3%) on the first day of January of each year unless or until a subsequent resolution is adopted wherein one or more new rates, fees, or charges are established.
