Monthly Charges A base (minimum) monthly fee is charged based on the size of the meter, even when no water is used. Usage is charged at the specified rate for each 1,000 gallons of water used. Charges for meters larger than 8" are determined on a case-by- case basis. Standpipe

Customers are charged a one-time \$25 fee at the time of each application for use. All usage is charged at the rate listed above for 500,001 - 1,000,000 to gallons. There is a minimum invoice amount of \$5. There is no connection or base charge.

Late Payments

Payments over ten (10) days past due will be assessed a fee of \$10.00. Payments over forty-five (45) days past due will result in the disconnection of water service. Overdue balances will be assessed interest of twelve percent (12%) APR.

Rate Increases

All rates, fees, and other charges described herein will automatically increase by three percent (3%) on the first day of January of each year unless or until a subsequent resolution is adopted wherein one or more new rates, fees, or charges are established.
