## Klickitat County Port District No. 1 **RESOLUTION NO. 2-2022**

## A Resolution of the Port of Klickitat Commission Designating Port Commissioner Districts

**WHEREAS**, the Port is divided into three commissioner districts, each required to be approximately equal in population pursuant to RCW 53.12.010; and

WHEREAS, the present commissioner districts are no longer approximately equal in population; and

WHEREAS, the Port is required to periodically redistrict its commissioner districts based on population information from the most recent federal decennial census pursuant to RCW 29A.76.010; and

**WHEREAS**, the Commission finds that the redistricting plan, attached hereto, meets the requirements of RCW 29A.76.010(4) insofar as:

- a) Each commissioner district is as nearly equal in population as possible to each and every other such district comprising the municipal corporation, county, or special purpose district;
- b) Each district is as compact as possible;
- c) Each district consists of a geographically contiguous area;
- d) Population data has not been used for purposes of favoring or disfavoring any racial group or political party; and
- e) To the extent feasible, and if not inconsistent with the basic enabling legislation for the municipal corporation, county or district, the district boundaries coincide with existing recognized natural boundaries and, to the extent possible, preserve existing communities of related and mutual interest; and

WHEREAS, a public notice was published in a newspaper of general circulation in Klickitat County during the weeks of June 13 and June 20, 2022, stating that a public hearing on the proposed redistricting plan would be held at the Port Office on June 29, 2022 at 4:30 P.M., pursuant to RCW 53.16.020; and

**WHEREAS,** a public hearing was held on June 29, 2022 at 4:30 P.M. in the Port Office Conference Room at which the Port Commission accepted comment from all persons desiring to be heard on the proposed redistricting plan pursuant to RCW 53.16.020;

**NOW, THEREFORE, BE IT RESOLVED** that the Port Commission hereby adopts the redistricting plan as presented at the public hearing and adjusts each commissioner district boundary as set forth therein. Furthermore, this revision shall not affect the qualifications or term of office of any sitting commissioner and shall be used at the next election at which a Port Commissioner is regularly elected, provided that it shall take place no less than 180 days after the new commission district boundaries are submitted to the Klickitat County Auditor.
